# THE PRESIDENT'S CORNER September 2024

In the past month our Club has experienced several cases of kennel cough. There can be as many as 100 dogs and their handlers on the premises throughout each day/evening. Certain measures of prevention are not being followed regarding the spread of illnesses among us and our dogs. We all need a reminder of those preventative measures. It is essential to adopt common sense hygiene and health practices. This is not meant to panic anyone but to raise awareness.

- **Regular Handwashing**: For humans, frequent handwashing with soap and water for at least 20 seconds is crucial, especially after touching pets, their food, or waste.
- Avoid Close Contact: If you or your pet is sick, it's wise to avoid close contact such as cuddling, kissing,
  or sharing toys, food and bedding. NO COMMUNITY WATER BOWLS. Would you drink from the same
  glass as a stranger? Ask your students to bring their own water dishes for use during class.
- Vaccinations: Keep up with recommended vaccinations for both people and pets. Vaccines are a key line of defense against many viral infections. I know there is a lot of controversy. Rely on your veterinarian for advice.
- Clean Environment: Regularly clean and disinfect surfaces and objects that people and pets frequently touch.
- **Responsible Pet Ownership**: Ensure pets are well-cared for, have regular check-ups, and maintain a healthy diet to strengthen their immune system. This also means stay home and or isolated if you or your dog are exhibiting symptoms of an illness.
- Awareness and Education: Stay informed about the symptoms of viral infections and the steps to take if an infection is suspected in you or your pet.

Instructors and assistants be aware of the health of the dogs and puppies in your class. If any are exhibiting signs of illness advise them to go home and seek the advice of their veterinarian. Follow up with them in case you need to inform any other members of the class.


By following these simple, common-sense measures, we can significantly reduce the risk of viral spread between people and dogs, ensuring the health and well-being of all.

# **GEAR HOUNDS: Cato vs Klimb**

# Cato Board vs. Klimb Platform: A Comparison





A friend contacted me stating she wanted to buy a training board, but couldn't decide between the Cato Board or Klimb Platform. She was drawn to the price point of the Cato but didn't know if she would regret not buying for the Klimb. While both serve similar purposes, they have distinct features that may make one more suitable than the other depending on your training goals and your dog's needs. Here are my views on both options.

# **Design and Construction**

Cato Board: The Cato Board is a flat, rectangle platform designed specifically for obedience training. It has either a non-slip rubber or artificial turf surface, depending on which you select. The surface can be changed, so purchasing both for one board would give you variety. The board's simplicity is one of its strengths, offering a clearly defined space for dogs to sit, stay, or place making it ideal for basic training exercises. The board's compact design makes it easy to transport, though it lacks an adjustable height. One of the best features is the rubber feet, which provide extreme



stability on most flooring surfaces. I use it in the house, because it will not scratch my hardwood floors.



Klimb Platform: In contrast, the Klimb Platform is more versatile and customizable, but less stable than the Cato Board. It features a square-shaped, side handles, an elevated surface with detachable legs that store quickly on the underside, allowing users to adjust the height of the platform to suit different training scenarios or dog sizes. I have found the surface to be more slippery than the Cato Board. The lack of rubber feet allows the platform to move when the dog slides into it at speed, especially on surfaces like laminate, hardwood, or tile.

# **Training Applications**

**Cato Board:** The Cato Board is primarily used for place training and basic obedience commands such as "sit," "stand," and "down." If you own a larger breed, it is very useful for training both fronts and finishes, as the platform is narrow enough to help form that nice, straight sit. It can be a tight fit for downs with large breeds, but it does help train a sphinx down. The board's simplicity and portability make it an excellent choice.



**Klimb Platform:** The Klimb Platform offers a broader range of training applications due to its adjustable height and larger surface area. It's not only used for basic obedience and place training



but also for agility training, trick training, freestyle, swimmers turn for flyball, and confidence-building exercises. The platform's elevated design challenges dogs to balance and navigate different surfaces, making it a valuable tool for advanced training and conditioning. Having the ability to screw on two of the four legs to provide an angled training surface is probably my most favorite feature of this platform. Additionally, my Fit Paw peanut fits nicely between the legs creating a stable workout surface for multiple exercises. I've included several photos below.

# Portability and Storage

Cato Board: One of the advantages of the Cato Board is its portability. Its compact design makes it easy to transport, and it can be used in a variety of settings, both indoors and outdoors. The board's lightweight construction means it can be easily moved from one location to another. The boards stack and take up little space, which is nice for group classes or multi dog households. I own three and when stacked, they take up less space than a single Klimb. Stacking Cato's does offer a way to increase the height and the stability is not compromised while stacked. Owning more than one board does allow for more training variations, as seen in this photo.





Klimb Platform: While the Klimb Platform is also portable, its larger size and detachable legs make it slightly less convenient to transport than the Cato Board. The legs often fall out of their storage area under the platform, which is a hassle. However, the ability to adjust the height and customize the platform's setup outweighs this slight inconvenience. The platform can be disassembled for easier storage or to reduce the height while training. I love the carry handles on the sides.

#### **Cost and Value**



**Cato Board:** At half the cost of the Klimb Platform, the Cato is a less costly option for dog owners who are looking for a simple, effective platform. Its value lies in its durability, ease of use, outstanding stability, and variety of surfaces. I've had the white board out on my patio for 3 years and while dirty, it is still in perfect condition. This alone makes it more valuable to me than a homemade wooden platform.

Klimb Platform: While Klimb Platforms are more expensive, it might be the right choice due to the versatility. For dog owners and trainers who need a tool that can adapt to various training needs, the Klimb offers great value. Its durability, combined with the adjustable height makes it a strong contender for those who want a flexible training solution. I won mine in a raffle, and I'm not sure I would have purchased one prior to owning it, because I had the Cato boards. With that said, I really see the value and flexibility. It does fill a slightly different niche.

# Conclusion: Which One is Right for You?



Choosing between the Cato and the Klimb depends on your specific training needs and goals. If you're focused on obedience training and you prefer a simple, durable, portable, and budget-friendly option, the Cato Board is an excellent choice. However, if you're looking for a more versatile tool that can grow with your dog's training progress and be used for a wide range of exercises, the Klimb Platform offers more flexibility and advanced features.

Both tools are highly effective, and the best choice ultimately comes down to your training style, budget, the dog's needs, and your long-term training objectives.

You absolutely can build an inexpensive platform for a fraction of the cost.

However, if you want something that requires zero work and can be left out in the weather without risk of damage, either of these platforms would do the job.

# **AGILITY GRAND CHAMPIONS!**



Two Agility Grand Champions in 3 weeks!

My old boy Argyll finished his Agility Grand Champion on Sunday July 14th and my young boy Finn finished his on Sunday August 4th.

The Agility Grand Champion (AGCH) is the highest title in AKC agility. To achieve it the dog must succeed in all the games at the highest level. It requires 100 master standard, 100 master jumpers, 75 master FAST, 75 T2B, 50 premier standard and 50 premier jumpers.

I had never competed in either of the premier classes but in the spring of 2022 I decided that we would give it a try. I was hoping

that Argyll would get the title. He was already 8 1/2 years old at the time so I knew that his agility career wasn't going to last many more years. Finn wasn't quite 2 years old yet, so I had plenty of time with him.

We had a few bumps on the road, starting in May of 2023. I injured knee and was unable to run for 2 months. However, after a little training both boys became willing to run with my friends. Then in the spring of 2024, Argyll's arthritis flared and he was unable to run for about 5 weeks over a 2 month span. Then at the end of June, my knee became a problem again and I was unable to run. My friends came to our rescue again and kept the boys running.

July came and I still couldn't run but Argyll needed only 3 premier jumpers to finish his title. Andrea Ford and Kelly Hall were able to run him that weekend. By Sunday he had 2 of the legs, so he needed just 1 more. I made the decision to have Kelly Hall try for his last ribbon and they did it. It was the best decision I could have made.



That left one to go for Sunday and my knee was slowly getting better. So I decided that I was going to try and we did it.
